

TimeLog data transfer to and from Microsoft Dynamics NAV

This section contains information about fields in TimeLog that are transferred to which fields in Microsoft Dynamics NAV. Please be aware that Navision has restrictions on the number of characters in various filed names which have important on the data transfer.

Customers

Existing customers are to be linked or imported when the integration is configured before activation. Depending on the integration configuration is the customer data added and updated automatically from NAV to TimeLog or from TimeLog to NAV when invoices is transferred.
